# Terms and Conditions

# Transportation to and from Chiba

Program participants are responsible for their own transportation to and from Chiba, Japan. Chiba University is not responsible for any loss or additional expenses incurred due to delay or change in services due to illness, weather, transportation strikes, quarantine or other causes beyond the University's control.

# <u>Payment</u>

Payment information will be provided after the enrollment has been confirmed and the payment deadline will be no later than 5 weeks before the start of the program. Participants are responsible for making necessary arrangements for payment.

# Cancellation & Refunds

If a participant withdraws from the program, the following cancellation and refund policy will be applied:

 $\cdot$  Cancellation notice 21-8 days before the arrival, 20% of the total amount will be charged

- $\cdot$  Cancellation notice 7 days before the arrival, 30% of the total amount will be charged
- •Cancellation notice 1 day before the arrival, 40% of the total amount will be charged
- •Cancellation notice at the arrival date, 50% of the total amount will be charged
- $\cdot$  Cancellation without notice, 100% of the total amount will be charged

Before refunds are processed, any processing fees incurred will be deducted from the total fees. Also the following cases are deemed as cancellation:

 $\cdot$  If required documents are not sent by the designated date.

 $\cdot$  If required payment is not made by the designated date.

· If applicant does not respond to request sent by Chiba University by given deadline.

·If Chiba University finds that there is a falsehood or an important omission in an applicant's documents.

·If Chiba University finds that an applicant is unsuitable or has an inappropriate attitude for the program after his/her arrival in Japan.

## <u>Travel insurance</u>

#### Visas

Program participants are responsible for obtaining all necessary visas prior to arrival in Japan. Chiba University will send an invitation letter and other required documents as needed after the enrollment and payment have been confirmed. Participants will also be expected to prepare the necessary documents on their own. Obtaining a visa may take time. Prospective participants are therefore advised to pay prompt attention to the visa application procedures and prepare the necessary documents as soon as their participants hold a visa which will remain valid throughout the duration of the program or if they are a citizen of a country which has a visa exemption agreement with Japan. For more information, participants should contact the nearest Japanese Embassy or Consulate.

#### Privacy Policy

Chiba University will not use the personal information for any purposes other than the program. Chiba University will not share or sell the personal information to other agencies except for the necessary preparation procedures (e.g. arrangement of accommodation and activities for the program).

#### Promotional Photography

Chiba University reserves the right to take photos during the program and use these photos for future promotional purposes. Participants who wish to not be photographed should inform the program staff at the beginning of the program.
